This contract is between Sarah Forbes of St Michaels Avenue, Yeovil, BA21 4LP hereafter referred to as The Seller, and (Name of Buyer) of (Address), hereafter referred to as The Buyer.

By signing this agreement and or paying the non refundable deposit, the buyer confirms that she has read this agreement and understands and agrees to these terms and conditions. This agreement is binding and drawn up in duplicate. Each party is given a copy and must be retained.

1. PUREBRED GUARANTEE.

The Seller declares that the subject matter of the purchase is a purebred Bengal Cat. The purchase is eligible for registration with TICA and the TICA registration papers (transfer) will be held by the Seller until the payment and related fees are made in full. The Seller guarantees that the information on the TICA registration (Dam & Sire) is correct.

2. HEALTH GUARANTEE

The Seller declares that the subject matter of the purchase is in good health at the time it are received by The Buyer. The Seller is not aware of any visual or hidden health defects or diseases. The animal will be de-wormed at 2,5 and 8 weeks with Panacur. The animal will be given Stronghold or Advantage at 12 weeks old which will cover fleas, worms and ear mites. The Animal will received a full course of vaccinations (Nobiva Tricat Trio + Nobivac FeLV) between 8 and 12 weeks. Kittens sold as a pet will be neutered at 12 weeks. The animal will be treated for fleas regularly using Frontline spray prior to Stronghold/Advantage at 12 weeks.

The Seller gives a 1 year guarantee for Hypertrophic Cardiomyopathy (HCM). The parents of the cats are regularly examined by a vet and are tested normal for Progressive Retinal Atrophy (PRA-b) and Pyruvate Kinase Deficiency (PKDef). The Seller cannot guarantee the permanent health condition or mishandling on the part of The Buyer. If the animal is to become ill or die before pickup, The Seller is bound to replace with another of equal quality and value, within The Sellers possibilities. All deposits are non refundable, though in this case they are transferrable to a new animal. Should there occur any genetic defects within 12 months of age, The Seller is bound to replace the animal with another of equal quality and value, within The Sellers possibilities, provided The Buyer proves this fact by a report from a licensed veterinarian. The Seller reserves the right to a second opinion from another licensed veterinarian. No cash refunds or buy backs are possible

3. RELATED BUYER RESPONSIBILITIES

The Seller recommends, and it is The Buyers responsibility to have the animal seen by a licensed veterinarian for a thorough examination within 72 hours from the moment The Buyer collects. If the licensed veterinarian confirms that the animal is ill, The Seller should be contacted before treatment has begun, expect in an emergency situation where the animals life is explicitly in danger. The Seller will not cover any fees related to immediate care or further treatment should there be a failure to inform the Seller within the 72 hour period. Failure to do so will forfeit any and all rights to compensation on the part of The Seller and must be returned to The Seller and failure to do so will be considered a breach of the guarantee conditions and will render any guarantee null and void and isn't subject to exchange for another animal. If the animal is recognised as a patient with 72 hours from the moment the animal is picked up then it is subject to replacement with an equivalent animal within The Sellers possibilities. The Seller cannot provide any guarantee or warranty against diseases potentially contracted from The Buyers household or other animals in The Buyers possession. The Buyer agrees that annual booster vaccinations is to be given to the animal to protect it against disease. Should the animal contract any diseases related to failure to vaccinate, The Seller is not responsible for any vet fees. The Buyer agrees that the animal is to be kept as an indoor pets and if The Buyer wishes to allow the animal to have time outside of the house, the animal is not to be left unsupervised (These terms can be discussed/amended depending on the location of the animals home). The Buyer agrees to give the animal suitable care, attention, entertainment, love and space to move freely. The animal must have access to clean water, food and clean bedding. If it is established that the animal is suffering neglect or abuse, The Seller has the right to repossess the animal from The Buyer without compensation for the animals. Whilst The Seller will raise the animal correctly, litter train and socialise the animal, behavioural problems (incorrect urination, defecation, scratching furniture etc) are not within The Sellers control and is therefore not considered a reason for return or refund. The Seller is happy to offer advice on any behavioural problems and will work with The Buyer to try and correct this behaviour. The Seller will always accept the unwanted animal but once the animal have a new home, The Seller is not liable to pay for damage caused by this behaviour as this is beyond The Sellers control. The Buyer agrees that the animal is not to be resold, rented or passed to a rehoming centre, research laboratory or similar object. The animal must be returned to The Seller in the first instance. It is recommended that The Buyer should purchase pet insurance for the animal.

4. BREEDER RESPONSIBILIES

The Buyer will not rehome any kittens that they produce with The Sellers kitten/s before 12 weeks of age at a minimum. The Buyer will fully vaccinate and microchip all kittens produced with The Sellers kitten/s before they are rehomed. If any kitten is unable to have a vaccination, The Buyer will keep the kitten in their possession until the kitten is able to be vaccinated. The Buyer will neuter ALL pet kittens produced with The Sellers kitten/s.

5. PAYMENT & DEPOSIT AGREEMENT

The Buyer agrees that any payment/deposit received by The Seller from The Buyer is non-refundable (e.g. cancellation). Should The Seller become unable to complete the sale prior to the collection, delivery and/or handover of the named animal, due to illness, death or birth defects whilst the animal is still at The Sellers premises, The Buyer has the option to transfer the deposit to another kitten of the same quality, no refund will be given. Should The Buyer choose to transfer the deposit to another animal, The Seller will offer an animal of comparable quality to The Buyer, either from the same parents or another queen who is due next or queens on current litters where comparable quality is possible within 6 months. The receipt of the deposit from The Buyer to The Seller will be considered as The Buyers agreement to the terms and conditions within this

contract. The remaining balance after a deposit has been received is to be paid

and cleared before the animals leave The Sellers premises, whether that is by

collection or delivery. If The Seller has not received the outstanding balance from

The Buyer, the animal will not leave The Sellers premises. The Seller is not

responsible for any delays in collection or delivery if the remaining balance has

not been received from The Buyer to The Seller.

5. DISPUTE RESOLUTION

Should there be any dispute between The Buyer and The Seller, The Buyer

agrees that all information is considered confidential and is and will only be

shared between The Buyer and The Seller. This confidential information will not

be shared with third parties, transmitted, copied, presented, or distributed

without the written consent of The Seller. The Buyer also agrees that all legal

disputes arising out of this contract will be resolved in The Sellers place of

residence.
